Detailed Regulation for collaborative R&D and interna cooperation based on UBT (Ubiquitous-based test) and UBL (Ubiquitous-based Learning) technologies.

Article 1

(Purpose)

This project aims to strengthen the reciprocal relationship between two parties in cooperative activities distributing education service based on u-learning platform include UBT (Ubiquitous-based test) to Mozambique.

Article 2

(Basic Principle)

The Parties shall cooperate so that they could create mutual common profit through the Project.

Article 3

(Good Faith)

The Parties shall faithfully perform this detailed regulation based on the principle of good faith.

Article 4

(Cooperation)

Scope of services to be performed by **the Parties** shall be as follows and shall be expended to other fields step by step.

- The Parties shall jointly implement Project with professors, experts, teachers, students and related organizations through utilizing technological resources and intellectual properties of "NSD" and the facilities and the human resources and the intellectual properties such as training contents, infrastructure of "UniLicungo".
- 2. "NSD" and "UniLicungo" shall provide information and R&D materials related to various tests and training content needed for Project.
- 3. "UniLicungo" shall provide facilities in "UniLicungo".and R&D materials related to various tests and training content needed for Project.
- 4. "UniLicungo" shall make a policy which related to the project for its success.
- 5. **The Parties** shall provide additional human resources needed for Project and its operation.
- 6. The Parties shall actively cooperate for joint research, academic activities and other related

activities in performance of the Project.

- 7. **The Parties** shall cooperate both in regular and irregular base by jointly establishing the Task Force team under this detailed regulation for the successful project.
- 8. "NSD" shall share the results of the project which are educational contents on the u-learning platform to other organizations in Mozambique and in overseas to achieve goal of the project.
- 9. When the profit sharing activity runs, the Parties shall share the profit to the Parties accordingly.
- 10. **The Parties** shall decide detailed agreements such as role allocation and methods of investment based on profit share (If the experience and knowledge shall be selling to other organizations) by separate agreement case by case.

A. Default role:

- "NSD" support U-Learning software platform, UBT Software platform, human resources, consultation, training program, and other related resources included investment of servers for its operation.
- "UniLicungo" support content developing resources, space and network connection for the cloud servers, custom clearance of supported goods, coordination in Mozambique, human resources and related resources included all administration matter such as VISA for NSD, Official position for the project in "UniLicungo".

Article 5

(Validity)

This detailed regulation shall be effective for (5) years from the date of signature by both parties.

Article 6

(Confidentiality)

During this MoU implementation, each party shall not provide or reveal any confidential data, information, and documents to the 3rd party. However, the Parties may disclose some information to the 3rd party according to mutual agreement when necessary for public relations, marketing, collaborative R&D and collaborative activities for earning the profit or purpose of investment.
